In exercise of the power conferred by sections 12 and 17 of the West Bengal Panchayat Elections Act, 2003 (West Ben. Act-XXI of 2003), read with rules 22 and 23 of the West Bengal Panchayat Election Rules, 2006, I, the District Panchayat Election Officer and District Magistrate of the district of HOWRAH, as the prescribed authority appointed by the State Govt. in the Department of Panchayats & Rural Development under notification No. 5316/PN-O/I/1A-3/2010 dt. 01-07-2010 for the purpose of the rules 22 & 23 of the said rules, hereby publish the draft of this order to determine for the Grams specified in column (1) of the Schedule below, the total number of members, Scheduled Castes members, Scheduled Tribes members, Backward classes members & women members to be elected to such Gram Panchayats specified in corresponding entries in columns 2(a), 2(b), 2(c), 2(d) & 2(e) respectively, to divide the area of the Grams into constituencies with serial numbers assigned to them specified in the corresponding entries in column (3), to allocate to each such constituency seat or seats specified in the corresponding entries in column (4), seat or seats reserved for the Scheduled Castes or Scheduled Tribes or Backward Class persons specified in the corresponding entries in column (5), and seat or seats reserved for women specified in the corresponding entries in column (6) of the Schedule, for information of the persons likely to be affected thereby.

The draft will be taken up for consideration after fifteen days from this day and any objection or suggestion with respect thereto, which may be received by the undersigned within the said period, shall be duly considered.
